AGREEMENT LETTER

Dated: 30th April 2024

This letter serves as a formal agreement between **Eagle Eye Investment Group (herewith referred to as Eagle Eye)** and **Shamim Khan, Chairman New Lynn Islamic Centre** located at **13 Ward Street, New Lynn, Auckland**, whereby Eagle Eye will provide professional services for the slaughter of Lamb, Goat and/or Cattle for Eid ul Adha in 2024. The slaughter will only be done post Eid Salath in New Zealand as per local Eid ul Adha celebration and on the day after Eid. The official confirmation of Eid day will be established by the FIANZ Hilal committee post sighting of the Hilal for Dhul Hijjah 1445H in June. Eagle Eye will also be responsible for ensuring the distribution of slaughtered animals in well needed areas in Ethiopia, Kenya and/or Somalia on Eid day and day after Eid.

All inclusive cost for Qurbani and Distribution		
Lamb or Goat	NZ\$ 125 per animal	1 animal per person
Cattle	NZ\$ 450 per animal	7 shares per animal

Brother Shamim Khan and/or his nominated delegates will be responsible for collecting funds from the New Lynn Islamic Centre community for this overseas Qurbani. The details of collected funds along with how many animals need to be slaughtered will be shared with Eagle Eye no later than **10th of June, 2024**. **Eagle Eye** will be required to provide written confirmation of receipt of funds no later than **11th of June, 2024**.

Payment Terms

Payment shall be made as per agreed schedule of payment outlined above which will only come into effect post signature of the contract.

Payment guidelines

All the payments of the project will be collected in the account for New Lynn Islamic Centre and disbursed through cross bank transfer or certified remittance companies and according to the procurement policy of **Brother Shamim Khan, Chairman New Lynn Islamic Centre**.

Brother Shamim Khan and his delegates will visit the farms to monitor the progress of the project. Please sign all copies of this agreement. Each party must retain one copy of the signed agreement.

Contract Addendum

Expectation and Commitment from Eagle Eye that will be facilitating the Qurbani via Barookhle Ranch

- The animals will be provided necessary health care and will be well guarded from the time of purchase until slaughtering.
- Eagle Eye and Barookhle Ranch Investment Group will provide a letter to specify that all labour participating in the qurbani implementation understand the **Sharia requirements** of this project.
- A suitable place will be utilized to keep the livestock where they will be fed and provided with water until they are slaughtered.
- Eagle Eye and Barookhle Ranch Investment Group must provide photographic proof of animals slaughtered and distributed.
- Eagle Eye and Barookhle Ranch must provide photographic evidence of people receiving the qurbani meat.
- All veterinary certificates will be readily available for inspection by **Brother Shamim Khan and/or his nominated delegates from New Lynn Islamic Centre.**



In the effort of **Brother Shamim Khan, Chairman new Lynn Islamic Centre**, expanding the reach of support to underprivileged communities, one of the locations that the NGO can consider for its Qurbani Project in 2024 is Dadaab Camps, Kenya

Dadaab Refugee Complex is in Northeast Kenya, established in 1991 at the time when refugees fleeing the civil war in Somalia began crossing the border into Kenya for protection and shelter. The Complex contains three camps namely Dagahaley, Ifo and Hagadera. It is among the biggest refugee camps in the world as it has a population of 218,873 registered refugees and asylum seekers as at the end of July 2020.

The distance between Barookhle Ranch farms along Tana River- Kenya to Dadaab Complex is of range of 100km to 200km. There are two paved roads (B8 and A3) connecting the farms to targeted communities.
